**Introduction**

The Umpqua Valley Arts Association is proud to present our 46th Annual Summer Arts Festival, the largest arts festival in Douglas, Coos and Curry Counties. This eagerly anticipated celebration of the arts is well attended with a nominal \$3 per person or \$10 family rate at the gates and is strongly promoted with a 25K marketing plan including; newspaper coverage, television coverage, radio and public interest. The Arts Center, which rests in the center of historic Fir Grove Park, is in the heart of Roseburg. The Arts Festival Artisan Marketplace can accommodate up to 130 fine artists and craftspeople from around the country. Artists will offer work in a wide variety of juried mediums including painting, ceramics, glass, jewelry, wood, photography, fiber, metal and more. In addition to the Artisan Marketplace, the McMenamins Food Court features 10 or more food vendors plus beer and wine. Free performances by regional acts will be presented on both the Family and Main Stages. This three day Arts Festival hosts at least 12,000 people over the course of the weekend. We are dedicated to providing you, the exhibiting artist, the support needed to experience an enjoyable and profitable weekend.

**Festival Dates & Hours**

**Festival Dates & Hours:**

The dates of the Festival are Friday, June 27, 2014 from Noon until 8pm, Saturday, June 28, 2014 from 10am to 8pm and Sunday, June 29, 2014 from 10am to 4pm. The McMenamins Food Court and entertainment on the Main Stage will remain open until 9:00pm on Friday and Saturday nights and Sunday afternoon until 4pm.

Entertainers will perform on the designated stage in the time slot selected by the entertainment committee; **no exceptions.**

No animals, bicycles or skateboards on Festival grounds; **no exceptions.**

No overnight camping is allowed in Fir Grove Park; **no exceptions.**

No smoking; Fir Grove Park has been designated a No Smoking zone by the City of Roseburg; **no exceptions.**

**Jury**

Entertainment chosen is based on what the festival committee deems the right fit for the particular stage considered along with the festival budget and what would enhance the festival all around. It is the goal of the committee to offer a fresh round of entertainment. **Photos of your group along with a sampling of your music is highly encouraged.** Photos and demo's will not be returned.

Entertainers are encouraged to send in applications ASAP.

Entertainers are responsible for bringing their own instruments, music stands, stools (if needed), props and costumes. If musicians have unusual sound needs please state this on your application. Entertainers are encouraged to be prepared for any inclement weather with appropriate personal rain gear, or sunscreen, hats etc. Heat can be a factor as well, come prepared.

Time slots run between 2 to 3 hours and are staggered between the two stages. If accepted, full details will follow. Entertainers are required to be at the designated festival staging area a half hour prior to performance in order to board stage, sound check and/or warm-up. All entertainment remains on the time schedule put in place by the entertainment committee. All sound is provided by a hired professional.
